**Sub: Quotation for Hot Air Ballooning for 400 persons from 23<sup>rd</sup> to 29<sup>th</sup> October**

The District Olympic Association, Chhindwara, Madhya Pradesh is organizing Adventure sports festival 2009 at Tamia –Patakot from 23<sup>rd</sup> to 29<sup>th</sup> October 2009 for tribal children, students and other tourists. Madhya Pradesh Tourism development Corporation Limited and Madhya Pradesh Eco Tourism development Board are our partners in organizing this event. The event is proposed to be inaugurated by Tourism minister, MP government and other cabinet ministers of MP government.

Quotations are invited by **5pm, 08.10.09** from DGCA license holders for organizing Hot Air Ballooning (Tethered) at Patakot, Chhindwara from **23<sup>rd</sup> to 29<sup>th</sup> October**. The quotation offer should provide lump-sum cost for arranging hot air ballooning for 400 persons during event. The conditions shall be as follows:

1. The balloon should have DGCA certificate. The pilot should have license and the agency shall have to obtain requisite permission for organizing the event at Patakot.
2. The offer should reach the office by 5pm, 08.10.09. The offer should include specifications of balloon, the DGCA certificate, the pilots details and copy of license and experience in organizing hot air balloon.
3. The agency shall have to arrange for hot air ballooning for 400 persons. The minimum flight time per person should be approximately 10 minutes.
4. The agency shall have to bring at least one hot air balloon with minimum capacity of 8 persons or two balloons of capacity of 4 persons each.
5. The agency shall have to arrange for group insurance of the participants with minimum insurance of 5 lakhs per participant.
6. The agency shall be permitted to offer hot air ballooning to other tourists visiting the event. The rates have been fixed by DOA, Chhindwara as follows: Rs. 300 for students and Rs. 600 for others. The agency shall not be allowed to charge higher than this rate.
7. In case offer is approved the agency shall have to deposit an earnest money of Rs. 25,000 (Twenty five Thousand) in form of Demand Draft/ other security before the work order is issued.
8. Any advance required by the agency shall be provided only after the balloon arrives on site.
9. The agency shall be provided one room for pilot and one tent for other staff.
10. The decision of the chairman, executive committee District Olympic Association shall be final in case of any dispute.
